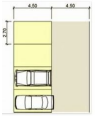

_____ A member or representative of the Faith Farmer's Market may inspect my farm/operation for check & verification of products that I have grown, made or sell. Produce or products may be turned down for poor quality.

_____ Vendors need to be in their designated, marked area no later than 7:30 am on Market days.

_____ Vendors are responsible for notifying the Market Manager or their designated representative if their arrival time to the Market will be later than 7:30 am.

_____ Vendors arriving to the Market after 7:30 am will be required to set up in a vacant spot at the end of one of the vendor rows.

_____ I will provide my own tent, tables, table covers and chairs.

_____ My helpers & I will be properly dressed & will deal with the public in a courteous and appropriate manner.

_____ All display items (signs, etc.) must be contained within the vendor's 12' x 12' space to prevent potential trip hazards.

_____ I agree to pay my market fees by the Friday before the market, each week.
